Your rights on the processing of your personal data (according to art. 15 ff. GDPR):

- You can withdraw your consent to participate at any time without giving reasons and without further consequences (see contact details at the top of page one).
- You can also withdraw your consent to the processing of your personal data by us at any time (Art. 21 GDPR). If the legal requirements are met, we will no longer process your personal data.
- Upon request, we will inform you whether we process your personal data. If this is the case, you have the right to receive information about this personal data as well as other information related to the processing (art. 15 GDPR).
